This Summary of Material Modifications (“SMM”) is intended to notify you of an administrative change to the dental plan provided by the New York City District Council of Carpenters Welfare Fund (the “Welfare Fund”). Please read this SMM carefully and share it with your family. You should keep it with your Welfare Fund Summary Plan Description (“SPD”) and other SMMs. The effective date of this change is January 1, 2018.

Change in Dental Plan Administrator Options Effective January 1, 2018

Under your current dental plan, you have the option to select one of three dental administrators. You are currently required to select a dental administrator when you first enroll in coverage. Due to the following upcoming change, this will no longer be necessary.

Effective January 1, 2018, Self-Insured Dental Services, Inc. (“ASO/SIDS”), one of the three current administrators, will administer all dental coverage under the Fund. Healthplex Inc. and Sele-Dent Inc. will no longer be available as optional dental administrators. If you currently use the Healthplex Inc. or Sele-Dent Inc. networks, this change may affect your current network of dentists. However, it will have **no** impact on your actual dental benefit. All coverage details will remain the same. To find dentists participating in the ASO/SIDS network, you can visit www.asonet.com or call at (800) 537-1238.
